SOLAR23 intends to award a supply contract for the supply and delivery of $360 \, kWp$ solar power plants (2 plants of $120 \, kWp$ and 2 plants of $60 \, kWp$), and $2252 \, SHS$ ($80 \, / \, 160 \, Wp$) in central province, Zambia, for the villages of Lyombe, Waya, Mumba Chala and Kaswende..
